Introduction

This privacy policy explains how AKTS is collecting and treating your personal data. We are committed to the responsible handling of your personal data. We therefore consider it a matter of course to comply with the legal requirements of the Swiss Federal Data Protection Act (FDPA), the Ordinance on the Federal Data Protection Act (OFDPA) and the General Data Protection Regulation of the European Union (GDPR). What we collect

Personal data

When you contact us by phone, e-mail or by filling our online contact form, we collect the following information in order to respond to your request:

- Name
- E-mail address
- Phone / Fax number
- Company name and address

Technical data

When you activate any AKTS software, we collect the following information in order to generate the software license:

- Anonymized information concerning the hardware of your computer
- For online software activation: the IP address used for the activation

Technical data

When you are browsing our website, the following data are automatically collected for anonymous usage statistics:

- Provider
- Country of origin

How we use your data

Usual business and customer support

If you fail to provide personal data

- Be informed within 72 hours in case an intrusion is detected in our system
